- 2. A site visit will be scheduled and a preliminary letter will be drafted for the city with necessary requirements for the modification of the company ditch.
- 3. Submit final construction drawing set along with a subdivision plat and any necessary easements or agreement letters by Mail, Drop-off or Email as listed above. The final set of plans will be required to be signed by the irrigation company representative for approval and should include:
 - a. a site plan showing all ditches, structures, piping and proposed modifications.
 - b. plan and profile drawings of new piping or channel relocation. Please show any utility information as it relates to the profile.

- c. irrigation structures with details as to size, rebar, invert elevations and cover.
- d. diversion structures must include sealed screw type headgates.
- e. proposed piping must include clean out access every 400ø and at all bends in the pipe.
- f. legal description of easements for new facilities.
- g. signature line for Lehi Irrigation Company.
- h. provision for any reconstruction or modification to existing access for operation and maintenance of existing facilities.
- i. additional agreements that may be required by city, county or state agencies.
- j. engineers estimate for cost of construction.
- k. reinforce concrete pipe unless otherwise approved by the irrigation board.
- 1. no drainage is allowed into irrigation ditches through this application agreement, see separate agreement for drainage into ditches.
- m. proposed start and completion date, (main ditches must start after October 31 and be completed by April 1)
- n. documentation provided to irrigation company for all installed pipe passing a pressure test.

The final fees will be based on construction cost and will require an engineer of cost estimate to calculate.

APPLICATION FEES

- 1. Application fee for modification to canal, ditch, or drain (placing in pipe, box culvert, change in alignment or utility crossing):
 - Initial fee: \$1,000 for preliminary consultation
 - 10% of estimated construction costs or \$6,000, whichever is higher.
 - \$2,000 is refundable upon satisfactory & timely completion.
- 2. Small subdivision or single lot application fee ó defined as three lots or less:
 - Initial fee: \$1,000, with \$500 refundable upon satisfactory & timely completion of project.
 - 10% of estimated construction cost if project moves forward. If costs are more than paid applicant is invoiced for remainder.
- 3. Fee of \$1,000 for starting without an agreement or signed set of plans.

The refundable portion of the application fee will be available at the completion of the irrigation season following the satisfactory completion of the project and a copy of record drawings to the irrigation company. The fees listed above will be used by the irrigation company for review, coordination, administration and inspection expenses. Please make checks payable to the **Lehi Irrigation Company.**
